- (b) to our knowledge, no litigation is pending or threatened (i) to restrain or enjoin the collection of revenues pledged under the Loan Agreement, (ii) in any way contesting or affecting the authority of the County to perform its obligations under the Tax Exemption Certificate and Agreement, Loan Agreement or the Bond Purchase Agreement or the validity of any of the foregoing, (iii) in any way contesting the existence or powers of the County or the Legislative Authority of the County or the title of any of the members or officers of the County or the Legislative Authority of the County to their respective offices;
- (c) the resolution of the Legislative Authority of the County authorizing the execution, delivery and performance of the Tax Exemption Certificate and Agreement, the First Amendment to Bond Purchase Agreement and the First Amendment to Loan Agreement has been duly adopted by the Legislative Authority of the County and has not been modified, amended or repealed;
