Each entry will consist of one person.

Categories include **ages 4-9, ages 10-13, ages 14-17, and 18 and above**

Advance registration is required and is due by midnight Wednesday, July 20.

**1)** Art must be family-friendly; No nude or lewd artwork **2)** No stenciling **3)** Only solid, non-toxic pastels (chalk) or sidewalk chalk can be used **4)** No political or commercial advertising statements are allowed **5)** 58" x 60" sidewalk blocks will be assigned based on registration **6)** Participant is limited to one block; no group projects **7)** Sidewalk art must be completed between 10:00 a.m. and 1 p.m. on Wednesday, August 3. Rain date is Thursday, August 4.

### Participants:

**1)** are required to complete and sign event forms (registration, liability waiver, media and press release) **2)** between ages 4 and 18 must have parent/guardian signature on all event forms **3)** must provide their own chalk **4)** may design and practice their chalk art on paper or sidewalk at home prior to the contest **5)** may use sketches as a reference during the event

### Judging:

**1)** is based on theme interpretation, first impression, creativity, originality, skill and use of color **2)** is based on the opinions of a select group of recognized local artists **3)** decisions of the judges and organizers are final

### Organizers:

**1)** have the right to disqualify and/or remove any inappropriate art or writing, as they may deem necessary **2)** are not responsible for accidents, stolen objects, or damage to art work **3)** will take digital images of the top three artists and artwork in each category for a community birthday calendar and/or greeting cards published by Union City Psi Chapter of Tri Kappa **4)** will award winners with ribbons and two copies of published works **5)** have the right to modify or add to these rules, as necessary
